

Sweepstakes Rules

1. Eligibility

LadderAnchor Sweepstakes (the "Sweepstakes") is open to legal residents of the fifty(50) United States and the District of Columbia who are at least eighteen (18) years old at time of entry.

Employees of The Product Foundry and other companies associated with the promotion of the Sweepstakes and their respective parents, subsidiaries, affiliates, and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations.

2. Sponsor

3. Agreement to Official Rules

Participation in the Sweepstakes constitutes entrants full and unconditional agreement and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. 4. Sweepstakes Period

The Sweepstakes begins May 14th, 2018 at Noon and ends July 01, 2018 at Noon (the "Sweepstakes Period"). Entries that are submitted before or after the Sweepstakes Period will be disqualified. Submission will be accepted for the duration of the Sweepstakes using the following method: Online.

5. How to Enter

Online: This method of entry will be available by visiting our website (www.ladderanchors.com/sweepstakes) and following the directions provided to fill out the entry information and submit.

Limit one (1) entry per person, per email address, and per household for the duration of the Sweepstakes Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become property of the Sponsor and will not be acknowledged or returned.

6. Prize Drawing

On or about July 02, 2018, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the numbers of entries received. The Sponsor will attempt to notify the potential winner via email on or about July 02, 2018. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email. If a potential winner cannot be contacted, or prize is returned as undeliverable, potential winner forfeits the prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize to his/her parent or legal guardian. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. 9. General Conditions

The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

By participating in the Sweepstakes, entrants agree to release and hold harmless the Sponsor, and each of the parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Sweepstakes, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of the prize (including any travel or activity related thereto), including but not limited for (a) any technical errors associated with the Sweepstakes, including lost, interrupted, or unavailable internet service provider (ISP), network, server, wireless service provider, or other connections, availability of accessibility or miscommunications or failed computer, telephone, cellular tower or cable transmissions, lines, or technical failure, or jumbled, scrambled, delayed, or misdirected transmission or computer hardware or software malfunctions, failures or difficulties (b) unauthorized human intervention in the Sweepstakes; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads; (e) any other errors or problems in connection with the Sweepstakes, including, without limitation, errors that may occur in the administration of the Sweepstakes, the announcement of the winner, the cancellation or postponements of the event, if applicable the incorrect downloading of the application, the processing of entries application or in any Sweepstakes-related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be cause, directly or indirectly, in whole or in part, from entrants participation in the Sweepstakes or acceptance, receipt, or misuse of the prize (including any travel or activity related thereto). All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with the laws of Kansas, without giving effect any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Kansas.
